

Omo Top Load Promotion Terms & Conditions

Please read this document carefully. It contains important information about your rights and obligations, as well as limitations and exclusions which may apply to you.

1. Information on how to claim and information to the offer form part of these terms and conditions. Participating in this offer is deemed acceptance of the Terms and Conditions of entry.
2. This offer is only open to Australian residents. The directors, management and employees and their immediate families, of the promoter, its related companies, agencies, suppliers and Whirlpool retailers are ineligible. Offer only available to consumers and not available to businesses or commercial buyers.
3. The promoter reserves the right at any time during / or after the closing to verify the validity of claims and to disqualify any claimant who tampers with the claiming process or who submits a claim that is not in accordance with the Terms and Conditions of entry. Failure of the promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
4. Offer commences 1st August until close of business strictly on the 30th September (the offer period)
5. Redemptions is available from 1st August until close of business strictly on the 30th September (the offer period).
